SUBJECT: Hurricane Harvey (NR #12)

As of 12:45p.m. today, based on the latest National Weather Service forecast, Orange County Judge Brint Carlton, in coordination with all city mayors, has issued a voluntary evacuation notice for the following Orange County areas:

- All portions of Orange County west of Hwy 105 & south of Hwy 105 up to the city limits of Bridge City
- Rose City residents
- The City of Pine Forest residents
- Woodridge Country sections 3, 4, 5, and 6 (Mesquite, Lariat Loop, Lazy Lane, & Ashland)
- All portions of Orange County north of IH-10 and east of Hwy 87 (excluding any portions of Orange city limits)
- Woodland Ridge neighborhood (located off of N. Hwy 87)

Residents are urged to safely leave their homes with the potential to be displaced for several days. We want to encourage everyone, even those not in the voluntary evacuation area, to continue monitoring their local news and make informed decisions about your families' safety.

Officials are continuously monitoring the effects of Hurricane Harvey. Future forecasts may require additional areas being added to the evacuation order.

If you are in need of shelter, you will need to bring an ID, change of clothing, and medications. Additional shelter information will be made available soon.
