STANDING ORDER FOR ALL CIVIL HEARINGS IN JUSTICE OF THE PEACE, PCT. 3, ORANGE COUNTY TEXAS

IT IS ORDERED that all CIVIL hearings and trials will be conducted by videoconferencing through <u>zoom.us</u> and the court will host the hearing or trial.

IT IS FURTHER ORDERED that attorneys (if any) are responsible for ensuring that their client and witnesses are available on <u>zoom.us</u> to testify from a remote location.

IT IS FURTHER ORDERED that Pro-Se Litigants are responsible for ensuring that their witnesses are available on <u>zoom.us</u> to testify from a remote location.

IT IS FURTHER ORDERED that at least five (5) minutes before the hearing or trial is scheduled to begin, attorneys, parties and witnesses shall log in to the meeting on <u>zoom.us</u>.

Regarding Evictions Trials

IT IS FURTHER ORDERED that evidence shall be marked with exhibit stickers by the party presenting the evidence and emailed to jsimonton@co.orange.tx.us at least 24 hours before the scheduled hearing or trial or you can drop off a copy of the exhibits at least 24 hours before the scheduled hearing. Exhibits include but are not limited to lease, rental agreement, receipts, emails conversations, photos, text conversations or any other evidence that would support your case. Please start planning your case upon receipt of these documents and do not wait until we are in the middle of the trial.

IT IS FURTHER ORDERED that evidence shall be marked with exhibit stickers by the party presenting the evidence and emailed to jsimonton@co.orange.tx.us at least 24 hours before the scheduled hearing or trial or you can drop off a copy of the exhibits at least 24 hours before the scheduled hearing. Exhibits include but are not limited to contracts, receipts, emails conversations, photos, text conversations or any other evidence that would support your case. Please start planning your case upon receipt of these documents and do not wait until we are in the middle of the trial.

Exhibits include any evidence that would support your case. Please start planning your case upon receipt of these documents and do not wait until we are in the middle of the trial. If the Plaintiff plans to request a default judgment the request must be sent 7 days prior to the trial or hearing date by mail. We will not accept default judgments by fax or email.
